## Cancellation/Postponement Policy

In the event of cancellation or postponement by the client, we reserve the right to charge the following fees:

Notice Period of Cancellation/ Postponement	Fees Payable on Cancellation/ Postponement
Over 60-days	No fee
59 – 30 days	50%
29 – 14 days	75%
<14 days	100%

If there is a cancellation/postponement within **0 - 14 days, 100% of the fee will be payable.**

## Payment Terms

- The Diversity Trust CIC applies a net 30-day payment of invoice term.
